INITIAL INITIAL I agree to check in with the pro shop and obtain a receipt for each round prior to beginning play. I will not play from my home or any location other than the pro shop.

INITIAL INITIAL I understand and agree that all passes are nonrefundable and nontransferable.

\_\_\_\_ INITIAL      INITIAL I understand that Lakeview Golf Course (“LGC”) may combine singles and twosomes into foursomes, in LGC’s sole discretion, in order to maximize tee time scheduling.

\_\_\_\_ INITIAL      INITIAL I understand that use of my annual pass is based on tee time availability.

\_\_\_\_ INITIAL      INITIAL I understand that scheduled tournaments may affect tee time availability.

\_\_\_\_ INITIAL      INITIAL I have reviewed and will comply with all LGC rules and policies. I acknowledge that such rules and policies are subject to change, and I alone will be responsible for awareness of such changes and for my/my child’s compliance.

\_\_\_\_ INITIAL      INITIAL Whenever using a privately-owned golf cart at LGC, I will display my private cart trail pass on my golf cart, as directed, at all times.

\_\_\_\_ INITIAL      INITIAL Prior to playing at LGC or using its equipment, I will inspect LGC and its equipment, and if I believe anything is unsafe or beyond my/my child’s capability, I will not, and will not allow my child to, play or use the equipment.

\_\_\_\_ INITIAL      INITIAL I acknowledge that LGC is a public place, where visitors of diverse ages, abilities, and perspectives should feel welcome and comfortable. To this end, I and my child will refrain from profanity, indecency, violence, discrimination, defamation, threats, or communications inconsistent with Meridian’s community values.

\_\_\_\_ INITIAL      INITIAL I acknowledge that my and my child’s presence and play at LGC carries risks, some of which are unknown, and with that knowledge do assume all known and unknown risks and hazards of my presence and play at LGC.

\_\_\_\_ INITIAL      INITIAL On behalf of myself, my heirs, executors, administrators, assigns, and personal representatives, and those of my children, I hereby release and forever hold the City of Meridian harmless from any and all real or possible losses, claims, actions, judgments for damages, expenses, harm or injury to myself, to other persons, and/or to property incurred in relation to my/my child’s presence and play at LGC not attributable to the tortious conduct of the City, regardless of the manner by which such claim may be brought.
